

EVENT WAIVER, RELEASE & HOLD HARMLESS AGREEMENT

Assumption of Risk: I understand that any event hosted by Bohm Inc. (not limited to workshops, Tulsa Rage Room, Glass Smash) is a potentially dangerous event and may involve materials, tools, and activities with inherent risks. I accept any explicit or implicit risks as my own and agree to defend, indemnify, and hold Bohm Inc., DBA Tulsa Stained Glass, its associates, and sponsors (herein referred to as "Released Parties") harmless for any actions brought against them before, during, and after the event. I also understand that there is an inherent risk of injury, whether caused by me or someone else, during this event. I understand that some event features may be a trigger for seizure activity in some people and I assume the risk of potential seizure activity by participating. I agree to specifically assume all risk of personal injury, whether physical or mental or otherwise, as well as all risk of loss, theft or damage of personal property while participating in this event. I understand that if I am attending the event with a minor, I am responsible for the minor's safety and behavior at all times.

COVID-19: I automatically agree to assume all risks related to exposure to Covid-19 or any other disease. I will not participate if I am experiencing symptoms of Covid-19 or have been exposed to someone with it within the last 14 days.

Liability Release, Indemnity Agreement: For events where alcohol is present, I affirm that I have reached the legal age of 21 to consume alcohol and be on premises where it is distributed. Should I consume alcohol, I agree to drink responsibly and am encouraged to use a designated driver. The Released Parties are free from any liability due to my participation in events where alcohol is present, including consequences from my consumption of alcohol or the consumption of alcohol by others.

I hereby forever waive, release, covenant not to sue, and discharge the Released Parties from all claims resulting from the inherent risks of events hosted by the Released Parties or the ordinary negligence of the Released Parties that I may have arising out of my participation in the event. I also agree to indemnify and hold the Released Parties harmless from all claims, actions, suits, procedures, costs, expenses, damages, and liabilities, including attorneys' fees brought because of my involvement in the event and to reimburse them for any such expenses incurred.

Severability: If any term or provision of this document shall be determined by a court of competent jurisdiction to be illegal or invalid for any reason whatsoever, such provision shall be severed from this document and shall not affect the validity of the remainder of this document.

I authorize the Released Parties' personnel to secure emergency medical care or transportation when deemed necessary by event personnel and release and discharge event personnel and associated parties from any act or omission of negligence in rendering or failing to render any type of emergency or medical services. I agree to assume all costs of emergency medical care and transportation.

Intellectual Property Waiver: I hereby grant permission for use of photographic or video images of me during the event for use in advertising or promotion without compensation.

Rules: I agree to abide by all written and verbally communicated rules of the event and premises. I further agree to comply with all directions, instructions, and decisions of the event personnel. I understand that it is my responsibility to make sure I and minors accompanying me follow all laws at all times while participating in the event, including but not limited to laws regarding public consumption of alcohol and public intoxication.

Event personnel may immediately remove anyone who disobeys any rules, directions, instructions, decisions, or laws, or whose behavior endangers safety or negatively affects a person, facility, or property of any type or kind.

By signing, I affirm that I understand and agree to the above provisions. Further, I acknowledge that I understand all the language in this document and what I am doing by signing it on my behalf or on behalf of a minor. I would not sign this document or participate in the event without understanding this document or until I had been advised regarding it by my own attorney. I also certify that I and any minor on whose behalf I am signing, are physically and mentally capable of participating in the event.
